**WHEREAS**, the President and Board of Trustees of the Village Forest View have been presented with and reviewed the State Property Tax Appeal of First Midwest Bank for the property located at 5504 W. 47<sup>th</sup> Street, Forest View, Illinois 60402 requesting a \$194,518 reduction in their 2022 Cook County Property Tax Assessment; and

**WHEREAS**, the President and Board of Trustees of the Village of Forest View have found that if this reduction were to be granted it would substantially impact the finances of the Village of Forest View; and

**WHEREAS**, the President and Board of Trustees of the Village of Forest View, believe it to be in the best interest of the Village to intervene in this Property Tax Appeal before the Illinois Property Tax Appeal Board.

**NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF FOREST VIEW**, as follows:

Odelson, Murphey, Frazier and McGrath, Ltd. located at 3318 West 95<sup>th</sup> Street, Evergreen Park, Illinois 60805, is authorized to file a Request to Intervene on behalf of the Village of Forest View in the State Property Tax Appeal of First Midwest Bank, owner for the property located at 5504 W. 47<sup>th</sup> Street, Forest View, Illinois 60402 currently before the Illinois Property Tax Appeal Board as Docket No. 22-31318. Be it further resolved that Elizabeth Shine, Esq. may adopt the evidence presented by any party or present new evidence on behalf of the Village of Forest View.
