# MINUTES OF THE REGULAR MEETING OF THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF FOREST VIEW January 28, 2025

# **BOARD MEETING:**

#### 1. CALL TO ORDER:

The regular board meeting of the Village of Forest View was called to order by Village President Miller at 7:00 P.M.

## 5. **PUBLIC HEARING**

NOTICE IS HEREBY GIVEN that the President and Board of Trustees of the Village of Forest View will conduct a public hearing on January 28, 2025, at 7:00 p.m. at the Forest View Village Hall, 7000 West 46<sup>th</sup> Street, Forest View, Illinois. The purposes of the public hearing are to consider a proposed Annexation Agreement, annexation, and zoning of the property. The property consists of approximately 15.163 acres, has a common address of 5000 South Central in unincorporated Cook County, and is improved with a warehouse and related facilities. All members of the public will be heard at the public hearing regarding this annexation and zoning request. (Refer to Agenda Item # 1)

The Public Hearing was called to order by President Miller at 7:20 P.M. with the following Trustees in attendance: Trustees Grossi, Sudkamp, Hubacek, Ramirez, Nevarez, Liska.

Agenda Item # 1 – Memo from John Murphey regarding the proposed annexation of the Combined Warehouse property and to summarize the general annexation process and the three ordinance which the Village Board will consider and second to give an overview of this particular agreement and third to explain the relationship between the Village annexation and the Central Stickney Fire Protection District and will explain that the Notices were put into the newspaper as legally required. He will walk the board through the process of adopting the three pertinent ordinances for the meeting and will be available to answer any questions. Village Administrator DuRocher is requesting the board consider approving the following three ordinances:

In the meeting Attorney Murphey discussed the proposed annexation. Carl Ivanelli, owner of Combined Warehouse at 50<sup>th</sup> and Central since 1993 and his Attorney Peter Veros, who also represents Fed Ex gave a presentation. The village will be adding properties with a total equalized assessed valuation (EAV) of \$675.00 to our current EAV of \$112,857,464. We will be rebating a total of about \$50,000 on new property tax revenues of about \$117,000 over a five-year period for a net increase of \$67,000 and we will generate annual business license revenues of \$3,250 and the issue of de-annexing from the Central Stickney Fire Association. Mr. Ivanell stated that it is important to have Combined as a business partner, to improve our tax base and the long-term health of the village. He currently has (5) tenants who lease units at this property. Attorney Murphey mentioned that under the law the village will not see the taxes until next calendar year. Attorney Murphey asked the board and the public if they had any questions. Trustee Grossi asked Police Chief Zarate and Fire Chief Jones if he had any issues with the annexation. Police Chief Zarate stated that his department patrols and does not see any issues and Fire Chief Jones stated that his department has already been out to the warehouse with his inspector and does not see any issues.

In conclusion Attorney Murphey informed that board that if the board approves the Annexation Agreement, they could vote on all three Ordinances together.

President Miller asked if any member of the public had comment. No comments were received.
