**BE IT ORDAINED** by the President and Board of Trustees of the Village of Forest View, Cook County, Illinois, as follows:

**SECTION 1. Approval.** The President and Board of Trustees hereby approve a certain “Annexation Agreement” with Chicago Title Land Truste Company, as Successor Trustee to Northstar Trust Company, as Successor Trustee to U.S. Bank N.A., as Successor Trustee to Firststar Bank, as Trustee u/t/a dated August 18, 1998, and known as Trust No. 7108, in connection with the property described in said Agreement. Said Agreement shall be substantially in the form of **Exhibit 1** attached hereto and made a part hereof.

**SECTION 2. Authorization.** The Village President and Village Clerk are hereby authorized and directed to execute and attest, respectively, the Annexation Agreement.

**SECTION 3. Effective Date.** This Ordinance shall take effect upon its passage, approval and publication in pamphlet form as provided by law.
