A RESOLUTION TERMINATING THE “INTERGOVERNMENTAL AGREEMENT  
RE: 911 DISPATCH SERVICES” WITH THE TOWN OF CICERO

WHEREAS, on October 25, 2022, the Village of Forest View entered into an “Intergovernmental Agreement Re: 911 Dispatch Services” (the “Agreement”) with the Town of Cicero; and

WHEREAS, said Agreement is scheduled to expire by its terms on October 22, 2027; and

WHEREAS, Section 15 of the Agreement provides that the Village “may terminate its membership by providing at least three hundred sixty-five (365) days’ written notice to Cicero;” and

WHEREAS, the President and Board of Trustees hereby determine that it is reasonable to exercise this termination right at the present time;

**NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF FOREST VIEW AS FOLLOWS:**

**SECTION 1: Termination.** Pursuant to Section 15 of the Agreement, the Village of Forest View hereby terminates the Agreement effective three hundred sixty-five (365) days after this Resolution is delivered to the Town of Cicero.

**SECTION 2: Notice.** The Village Clerk is hereby authorized and directed to serve notice of this Resolution to the Town of Cicero either by certified mail or personal delivery.

**SECTION 3: Effective Date.** This Resolution is in full force and effect immediately upon its passage.
