Agenda Item #1 - Pursuant to Section 2 (c)(1) of the Open Meetings Act (collective negotiating matters)

Administrator Durocher discussed in the meeting that the Police Union Contract with FOP will end on June 30, 2025. The village was provided notice that the union wishes to renegotiate the contract and mentioned that we were two years into the current contract before it was approved. Attorney Murphey stated that he had not met with the union, and they will start negotiations soon.

John DuRocher reported to the board that ComEd is interested in obtaining an easement with the Village for purposes of having a pole at our public works yard on Oak Park Ave. Also discussed was the McCook proposal. Plans to replace the lead service lines by 2027.

Tanner mentioned that the village had eleven watermain breaks last year, and ten in 2023. It will cost approximately 10 million to replace the residential water mains that go into the house. There are 265 lead service lines that will need to be replaced.
