Police Chief Wiseman spoke regarding his request for the Boards' approval to hire Part-Time Police Officer William Margalus. Officer Margalus is retired after thirty-three years of service with the Cook County Sheriff's Office. He retired in December 2020 with the rank of Sergeant. William Margalus is currently employed as a Part-Time Police Officer with Palos Park and was previously employed as a Part-Time Police Officer in Forest View from 2010-2016. A background check and fingerprints were completed. The Cook County Sherriff's Office said that he was a good and reliable Officer.

A Trustee asked why Officer Margalus was refused when he wanted to return to the Forest View Police Department after his 2016 departure.

- Thanked the Public Works crew, William Hughes, Tanner Miller and Victor Dantino for the outstanding work clearing the snow. They worked late, came in early and did a great job. Their work is greatly appreciated.
- Reminder for our Residents; please do not throw the snow back in the street after Public Works has cleared the roads. This makes the roads unsafe for travel.

A Trustee asked if the levee was done also.

Superintendent O'Donohue stated there is still snow on the levee.

Village President Powell thanked Public Works for doing a great job keeping the Forest View streets very clean.

A Trustee mentioned how the Forest View streets are always clear and cleaner than any of our surrounding towns.

Village President Powell mentioned a sign located at 46^{th} Street and Oak Park Avenue that has graffiti on it.

Superintendent O'Donohue stated that they will take a look at the sign.

Village President Powell stated that the attorneys spoke to us and we informed them that we are not interested in the Village of Stickney taking over our Fire Department. The lawyers were relaying that information to the Village of Stickney.

A Trustee mentioned that he thought we were checking to see if that letter was authentic. He felt there were no steps taken to do that.

Village President Powell stated that he will not be investigating the letter. The letter was not signed and no one came into his office to address the letter or concerns.

Discussion ensued about the letter, the time frame since the letter was received and not knowing who wrote the unsigned letter.

A Trustee asked a question regarding the two Police Officer complaints.

Village President Powell stated that the Union could not make the January 18th meeting so it was rescheduled. The Trustees can't be involved with this situation until it is resolved between the Officers and the Union. After the meeting and the situation is resolved, the Trustees will be informed.
