AN ORDINANCE ANNEXING CERTAIN PROPERTY TO THE VILLAGE OF FOREST VIEW (COMBINED WAREHOUSE/5000 SOUTH CENTRAL AVENUE)

WHEREAS, the property described on Exhibit 1 attached hereto and made a part hereof (the "Subject Property") is located in unincorporated Cook County; and

WHEREAS, the Subject Property is contiguous to the Village of Forest View; and

WHEREAS, there are no electors residing on the Subject Property; and

WHEREAS, the owner of the Subject Property has petitioned to annex the Subject Property to the Village pursuant to Section 7-1-8 of the Illinois Municipal Code, subject to the terms and conditions of an Annexation Agreement; and

WHEREAS, the Village and the Owner have entered into said Annexation Agreement pursuant to which the parties agree that the Subject Property be annexed into the Village;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Forest View, Cook County, Illinois, as follows:

SECTION 1. Annexation. The Subject Property is hereby annexed to the Village of Forest View pursuant to Section 7-1-8 of the Illinois Municipal Code.

SECTION 2. Authorization and Direction. The Village President and Village Clerk are hereby authorized and directed to execute and attest, respectively, this Ordinance.

SECTION 3. Recordation. The Village Clerk is hereby authorized and directed to cause a true and correct copy of this Ordinance, along with an accurate Plat of Annexation, to be filed in the Office of the Cook County Clerk.

SECTION 4. Effective Date. This Ordinance shall take effect upon its passage, approval and publication in pamphlet form as provided by law.
