APPROVAL OF MEETING MINUTES: *February 2, 2023 Regular Meeting:* The Board reviewed the February 2, 2023 regular meeting minutes. A motion was made by Trustee Mikel and seconded by Trustee Kappmeyer to approve the February 2, 2023 regular meeting minutes as written. Motion carried unanimously by voice vote.

ACCOUNTANT'S REPORT – LAUTERBACH & AMEN, LLP: *Monthly Financial Report and Presentation and Approval of Bills:* The Board reviewed the Monthly Financial Report for the ten-month period ending February 28, 2023 prepared by L&A. As of February 28, 2023, the net position held in trust for pension benefits is \$6,264,575.32 for a change in position of \$3,291,733.50. The Board also reviewed the Cash Analysis Report, Revenue Report, Expense Report, Member Contribution Report, Payroll Journal and the Vendor Check Report for the period December 1, 2022 through February 28, 2023 for total disbursements of \$15,515.17. A motion was made by Trustee Kappmeyer and seconded by Trustee Mikel to accept the Monthly Financial Report as presented and to approve the disbursements shown on the Vendor Check Report in the amount of \$15,515.17. Motion carried by roll call vote.

Discussion/Possible Action – Cash Management Policy: The Board discussed the Cash Management Policy and determined that no changes are required at this time.

INVESTMENT REPORTS: *Marquette Associates:* The Board reviewed the FPIF Monthly Summary prepared by Marquette Associates for the period ending February 28, 2023. As of February 28, 2023, the one-month total net return is (2.6%) and the year-to-date total net return is 3% for an ending market value of \$7,474,009,308 The current asset allocation is as follows: Total Equity at 64.6%, Fixed Income at 28.9%, Real Estate at 4.9% and Cash 1.5%.

Statement of Results: The Board reviewed the IFPIF Statement of Results for the period ending March 31, 2023. As of March 31, 2023 the beginning value was \$5,435,552.40 and the ending value was \$5,511,674.30. The year-to-date net return is 2.05%.

COMMUNICATIONS AND REPORTS: *Statements of Economic Interest*: The Board was reminded that the Statements of Economic Interest were due by May 1, 2023.

Affidavits of Continued Eligibility: The Board noted that L&A has mailed Affidavits of Continued Eligibility to all pensioners. A status update will be provided at the next regular meeting.

NEW BUSINESS: Certify Board Election Results – Active and Retired Member Positions: L&A conducted an election for one of the active member positions and the retired member position on the Forest View Firefighters' Pension Fund Board of Trustees. Richard Mikel ran unopposed for the active member position filled by a retired member and Randall Kappmeyer ran unopposed for the retired member position and both were elected for three-year terms expiring April 30, 2026. A motion was made by Trustee McGuffey and seconded by Trustee Kappmeyer to certify the active member election results. Motion carried unanimously by voice vote.

BMO Harris Signature Card and Resolution Update: L&A provided the Board with the necessary forms to update the signers on the BMO Harris Bank account with the current Board members and municipal representative. A motion was made by Trustee Mikel and seconded by Trustee Kappmeyer to designate Trustees Laura McGuffey, Randall Kappmeyer and Richard Mikel a as signers on the BMO Harris Bank account. Motion carried by roll call vote.
